**FIRST SUPPLEMENTARY DECLARATION TO THE

WHEREAS, Jones Land Company, LLC was designated as Declarant under the Supplemental Declaration of Protective Covenants and Owners SubAssociation for the Single-Family Residential Development at Reunion as of record in Book 1649, page 389, Register's Office for Williamson County, Tennessee (the "Declaration"); and

WHEREAS, pursuant to Article XV, Section 3 of the Declaration, Declarant has the unilateral right to amend the Declaration from time to time; and

1. All references to Reunion in the Declaration are amended and changed to McKay's Mill. All references to The Single-Family Residential Development at Reunion Single-Family Subassociation in the Declaration are amended and changed to McKay's Mill Single Family Subassociation, Inc.
